

RULES OF THE DRAW

« RAFFLE LA VACHE QUI RIT SPORTIVE »

Article 1 : Game Organization

The association " Chablais Léman Sport Organisation ", domiciled at 71 Chemin de la Forêt 74200 Thonon les Bains, SIRET 84258360100013 is represented by Sébastien Medan, President of the association.

This association is the organizer of the cycloportive "La Vache qui rit sportive" which will take place on [May, 28 & 29th, 2022 in Lons-le-Saunier \(Jura\)](#). In addition to this organization, the association organizes a draw for a prize with a total value of [40.000€](#).

Article 2 : Purpose of the game

The game is free. An endowment of a total value of [40 000€](#) will reward at random a selection (draw) of participants.

The draw will be made among the registration forms for the " La Vache qui rit sportive " (all the GRAVEL and ROAD courses) and having worn the " La Vache qui rit sportive 2022" jersey during the events ([May, 28 & 29th, 2022](#)) (see "Conditions of participation"). The registration to the race is done on the website <https://cycloportive-lavachequirit.fr> or at the race village, on site, in [Lons-le-Saunier on May, 28 & 29th, 2022](#).

Article 3 : Date and duration

Registration for the [La Vache qui rit sportive](#) is open from [02/12/2021 to 29/05/2022, at 7:30 am](#). The draw will take place at the end of the ceremony, in the race village around [3pm on 29/05/2022](#).

Article 4 : Conditions & validity of the participation

The registration to the cycloportive implies the registration to the raffle of the event and the acceptance without reserve of the present rules in its entirety.

Thus, the draw is open to any person who has :

- Validated their registration to the event (medical certificate less than one year old or valid license - FFC,

FFT, UFOLEP, FSGT, FFTRI; majority or 16 years old or more with parental authorization). Any participation will be considered as invalid if the information mentioned at the time of registration (medical certificate, license, identity, quality...) does not coincide with the person who participated in the cycloportive " [La Vache qui rit sportive](#) ".

- Wearing the jersey of the event offered by the " [La Vache qui rit sportive](#) " during the event of the same name. The organizer will award a jersey of the race to the first [3000](#) registered (chronological order). The participants registered after the attribution of the total number of jerseys offered by the organization will not be excluded from the draw of the tombola.

- Respect the rules of the event. The organizer reserves the right to eliminate from the draw any participant who has not respected the rules of the " [La Vache qui rit sportive](#) ". (rules to be found on the website of the event).

- To have finished the race before the time barrier of 3:30 pm at the finish. People still on their way between the beginning of the draw (around 3pm) and their potential arrival before 3:30pm will not be excluded. The organization will take care to inform the participants still on the way.

Not allowed to participate in the draw, any person who has collaborated in the organization of the draw, employees of the organizer or subcontractors of the organizer and its affiliates and all persons who have received an invitation (100% discount coupon).

Except for the "GRAVEL" participants (Saturday's event), the presence at the draw at [3pm on 29/05/2022 in Lons-le-Saunier](#) is necessary to withdraw the prize. Winners must collect their prizes in person upon presentation of their identity card or any other document proving their identity photo. No prize will be sent nor exchanged in exchange of a financial sum. The person must come forward before the next prize is drawn. No prize will be awarded after the draw.

Article 5 : Designation of the winners

The bib numbers of participants who have complied with the conditions of participation will be deposited in a transparent box by the organization. The number will be unique for each participant and will not be put back in the ballot box once it has been drawn.

The drawing of lots will be carried out under the supervision of Mr. Sébastien MEDAN, President of the requesting Association or any other member of the Association in case of impediment and by the [Maire of Lons-le-Saunier](#). A third person under 10 years of age will be randomly designated among the public to perform the physical sorting.

1- The designated third person will draw successfully in the transparent urn 50 numbers that the organization will classify in the chronological order of arrival.

2- The designated third person will then draw a lot distributed in a second ballot box – except for the KIA car which will be attributed last.

3- The announcer will call the number previously drawn (step 1). The person will have 5 seconds maximum to show up. In case of absence (except for the GRAVEL participant) or wrong information about his/her participation, or any other breach of the rules of the game or the rules of the event, the person drawn will not receive his/her prize and the announcer will call the next number drawn (step 1)

4- If all the conditions are met, the partner will publicly present the prize (presentation of the prize in 1 minute and official photo with the winner) and then the announcer will resume the draw (step 2).

If the 50 numbers drawn in step 1 are exhausted, the innocent hand will go back to a second wave of drawing (20 numbers).

Article 6 : Remittance or withdrawal of the lots

The prizes awarded are personal and non-transferable. In addition, the prizes may not under any circumstances be the subject of any dispute on the part of the winners, nor of an exchange or any other consideration of any kind whatsoever. The prizes will be awarded directly after the results have been announced.

For the winners who participated in the GRAVEL event on Saturday and who are not present at the draw on Sunday,

the organization will contact them to arrange for their collection. These will be at the expense of the winner.

Article 7: Information or publication of the winners' names

The names of the winners as well as the photos of the prize-giving may be published on the website and on the event's social networks.

Article 9: Promotional operations

By accepting their prizes, the winners authorize the organizer to use their names, brands, company names and this for promotional purposes on any medium of its choice, without this reproduction giving right to any remuneration or compensation other than the prize won.

Article 10: Personal data

The personal data collected in the context of participation in the game are recorded and used by the organizer for the needs of their participation and the awarding of their gains.

In accordance with the "Data Protection Act" No. 78-17 of January 6, 1978, Participants have the right to access, rectify or delete information concerning them. Article 11 : Responsibility

The Participant acknowledges and accepts that the sole obligation of the organizer with regard to this prize is to submit the collected entry forms to the draw, provided that his/her participation complies with the terms and conditions of the Rules, and to award the prizes to the winners, according to the criteria and procedures defined in these Rules.

The organizer cannot be held responsible, without this list being restrictive, for any technical, hardware or software failure of any kind whatsoever, the risks of contamination by

possible viruses circulating on the network and the lack of protection of certain data against possible misuse.

Article 12 : Force majeure / Reservations

The responsibility of the organizer could not be incurred if, for a case of force majeure or independent of its will, the endowment had to be modified, shortened or cancelled. The organizer reserves the right to proceed with any verification that it deems useful, relating to compliance with the rules, particularly to remove any participant who has made an inaccurate or misleading statement or fraud.

Article 13: Disputes

The Rules are governed by French law. Any difficulty in applying or interpreting the Rules will be decided exclusively by the organizer. No telephone request or claim concerning the application or interpretation of these rules will be answered. Any dispute or claim relating to the Game and the draw must be made in writing to the following address Association

No dispute will be taken into account eight days after the announcement of the results.

Article 14 : Filing and consultation of the rules
